Counseling Process:

1. For online registration students should apply through the website-www.coayurved.bharatividyaapeeth.edu
2. Result (Merit List) will be displayed on the same website as per above schedule.
3. During Reporting the physical presence of the candidates is mandatory. Candidates should register their names in the attendance register kept at venue for admission process. The seats will be allotted only on the inter-se merit among the online registered candidates who are physically present at the time of Reporting.
4. The candidates should report between 10.00 am to 11.00 am. Only those candidates will be considered for counseling.
5. Candidates must be physically present during admission/verification of documents at the institute. Any Authorized person, in the absence of the candidate, will not be entertained.
6. Candidates should come along with original documents and two sets of photocopies as per institute profile in AACCC along with the prescribed fee in the form of D.D. / RTGS / NEFT, Cheque as detailed on the website.
