


- This University is one of the largest Deemed Universities in the country established u/s. 3

Rules for Admission to Post Graduate Diploma Courses in Ayurved

1. Application form

- a) A candidate desirous of taking admission for Post Graduate Diploma Ayurved courses is required to submit single prescribed online application form along with Online form fee of Rs. 2,000/- (fee is non-refundable)
- b) The application form is available online at following website http://bvuniversity.edu.in
 The candidates should strictly follow the instructions while filling up the application form online, and must read the instructions carefully before filling up the online application form given in Annexure II.

- e) An incomplete application form or an application form which is not accompanied by necessary payment will not be entertained and processed.
- f) The University will not be responsible for any delay or loss of application / admission card/counseling letter/any communication in transit. Such delays will not be condoned.

2. Institutional Quota Seats:

Fifty percent seats are reserved for Institutional Quota Category on the basis of Inter-se merit obtained by them in the Merit List.

3. Duration of the Post Graduate Diploma Course - 02years

4. Eligibility for Admission

- a) A graduate degree in Ayurved of any university/statutory body approved by National Commission for Indian System of Medicine (NCISM)and qualified in the AIAPGET 2022.
- b) The applicant should complete his / her rotating internship training on or before 31st December 2022.
- c) The candidate should possess a permanent registration with any State Medical Council in India or Central Council of Indian Medicine. If he does not have the same he will be required to obtain such registration within one month after admission to the P.G. course, failing which admission to P.G. course will be cancelled.

5. Basis of Selection

The selection shall be made strictly on the basis of rank obtained by eligible candidate in AIAPGET 2022.

6. Merit List

- b. The candidate has to login at the website to view their individual result with their respective login credentials.
- c. The candidates will not be informed telephonically about the counseling.

- 7. A) The allotment of the subject will be done as per merit and depending upon the availability of seat in a particular subject at the time of counseling of the candidate.

All candidates are required to produce original and the two sets of duly self-attested photocopies of the following documents at the time of counseling. The selected candidates will be required to pay the entire amount of annual fee on the day of counseling itself. COUNSELING AND ON-THE-SPOT-ADMISSION SESSION

- The counseling and on-the-spot admission session will be held at the Bharati Vidyapeeth (Deemed to be University) College of Ayurved, Pune-Satara Road, Pune-411 043 on the day and time mentioned in the Calendar of events.
- 2. Only the candidate and one parent/guardian will be allowed into the hall where counseling is held. The candidates will be called in the order of their merit and offered the seats available at that point in time. The candidate will be permitted to choose any of the seats available when his/her turn comes.
- 3. When all the seats in a given specality subject/course are filled, admission of students to that specality subject/course will instantaneously cease and Bharati Vidyapeeth (Deemed to be University) will not be responsible for non-availability of the seats and non-allotment to the rest of the candidates.
- 4. At the time of reporting for the counseling, the candidate is required to produce the documents (original and two sets of photocopies) listed above in list of documents required at the time of counseling and spot admission.
